Sir,

In continuation to the letter under reference (1) above and as per resolution of the 5<sup>th</sup> Meeting of the SFSMEC held on 29.06.2010, it is proposed to support farmers for installation of electrically operated STW as per norms of the scheme of NFSM-Rice and as such, you are requested to execute the scheme as hereunder expeditiously as per allocation for the districts, approved brands and guidelines enclosed here with.

A tentative estimate of the cost of commissioning of the pump set of lowest price is given below-

As per norms of Govt. of India, the maximum subsidy for installation of STW along with pump set and tenderization is Rs. 10,000.00 per unit or 50% of the total cost (installation with pump set and energization), whichever is less. Since the amount of Rs. 10,000.00 (Rupees ten thousand) only is lesser than 50 % of the total cost likely to be incurred on commissioning of Electrical Pump set as per the table above, a maximum subsidy of Rs.10,000/- will be admissible.

In case, the cost of the Pump set is higher than Rs. 10,000.00 (Rupees Ten thousand only), the cost exceeding Rs. 10,000.00 (Rupees Ten thousand only) will be borne by the farmers. The subsidy in the form of cost of Pump set or Rs. 10,000/-, which ever is less, will be borne by the department. Rest of the materials required will be purchased by the farmer himself and installed at his own cost.

You are, therefore, requested to take up the activities urgently for implementing the programme. A set of guidelines and forms designed for the scheme are enclosed here.

## **Annexure-I**

### **Guidelines for implementation of component of STW with Electrical Pump set under NFSM-Rice/Pulses :**

1. District Agricultural Officer will assess the available quantity and level of ground water in different circles with the help of Ground Water Board .
2. District Agricultural Officer will allocate the pump sets ADO circle wise and implement the component of STW with Electrical Pump set as given in the subsequent clauses.
3. Agricultural Development Officers will implement on first come first serve basis.
4. Any individual farmer or farmer's group having agricultural land, electrical connectivity in the village and capacity to bear beneficiaries share will be eligible to apply for pump sets.
5. The farmers /farmer's group who desire to have a new electrical pump set (not the replacement of existing pump set) will submit an application to District Agricultural Officer in prescribed format along with recommendation of President, G.P or V.C.D.C.(for Autonomous Council area)/VLEW and ADO .
6. DAO will sanction the application of the farmers keeping in view the number of pump sets allocated to his district.
7. The applicant, on receipt of sanction from the DAO, will arrange for procurement of all required materials for installation of the STW and materials required for electrical connectivity of the pump set.
8. On completion of installation and arrangement for electrical connectivity, the farmer will submit the application to DAO with the verification of ADO indicating his choice of pump set from amongst the approved brands.
9. The DAO will sanction the pump set.
10. The DAO will calculate the brand wise requirement of pump sets for his district from time to time. He will communicate his requirement to DA accordingly.
11. The DA will ask the concerned dealer/ company/firm to supply the pump set to the DAO concerned .The dealers will send warranty cards / operational manual etc along with the pump sets.
12. The Local engineering wing will furnish a certificate about the brand & quality as per specification.
13. The DAO will forward the bills along with the verification of Engineering Wing to DA immediately.
14. The Pump set will then be supplied to farmers by DAO. The farmers will commission the same.
15. The DA will arrange for release of payment as per norms and procedures.
16. VLEW/ADO will submit verification of commissioning to the DAO within one month from the date of supply of the pump sets by the supplier.
17. If the Pump set is not commissioned within one month, the same will be taken back by the DAO for supply to any other eligible farmer.
18. In case of loss/transfer of pump set by the farmers or refusal to commission DAO will lodge FIR against the farmer and take further necessary action.
19. In case the cost of pump set is higher than Rs.10,000.00 (Rupees Ten thousand) only, the cost exceeding Rs.10, 000.00(Rupees Ten thousand) will be deposited by the farmer or farmer's group in the form of bank draft drawn in favour of the dealer concerned and the same will accompany the indent for the pump set by the farmer.
