

**CHAPTER – 11 (Manual -10)**

The Monthly Remuneration received by each of its Officers and Employees including the system of compensation as provided in Regulation.

**11.1 Information about the monthly remuneration and compensatory allowance of the officers and employees and system of compensation as per regulation.**

No any remuneration has been paid to the officers and employees of this Directorate However, they have been paid monthly salary i.e. pay and other allowances as per Government rules and regulation for performing duties.

The Officers and employees working under this Directorate are entitled to draw the following pay and allowance as here under.

a) Pay – Pay fixed as admissible pay band plus grade pay as per R.O.P. Rules 2010

b) D.A.- As per Price Index – declared by the Government from time to time.  
Now 45% as on 31.12.2010.

c) M.A. – Medical Allowance at the rate fixed by the Government of Assam, from time to time.

d) H.R.A. – House Rent allowance as per order of the Government and according to the place of posting as per R.O.P. Rules 2010 as under -

City /town/ rural areas

(i) 15% - Guwahati/Dispur with the limitation as per rule

(ii) 12% - District/Sub-division with the limitation as per rule

(iii) 10% - Other places of Assam.

e) Hills allowance and remote area allowance } – The allowance is granted to the employees working in Hills and remote areas as under -

(i) Sr. grade/Grade I - Rs. 600/- p.m.

(ii) Grade II, III & IV - Rs. 480/- p.m.

f) Fixed travelling allowance – Fixed T.A. is granted to touring officers and staff who are required to tour extensively for audit within statutory jurisdiction or camp office and beyond this sphere of duty he may draw travelling allowance under proper sanction of the controlling authority as per rules.
